Prospective bidders should have an experience of having completed within five (5) years from the submission of bids, a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the approved budget for the contract adjusted to current prices using the National Statistics Office consumer price index. The Eligibility Check/Screening as well as the Preliminary Examination of Bids the non-discretionary "pass/fail" criterion shall be used. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent

provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).

The BAC will issue Bidding Documents upon payment of a non-refundable amount of Five Thousand Pesos Only (P 5,000.00) to the Sulu State College Cashier, Capitol Site Jolo, Sulu. Moreover, the Sulu State College reserves the right to reject any or all bid proposal at any time prior to contract award, waive any formality in the bid requirements, declare the bidding a failure, or award the contract to the bidder whose offer is the most responsive, lowest calculated bid, and most advantageous to the government.
